SARFAESI, 2002 – The Securitisation and Reconstruction of Financial Assets and Enforcement of Securities Interest Act, 2002 is an Indian law. Under this, banks and other financial institutions can auction the Security Interest created in residential/commercial properties (of Defaulter) to recover loans. It does not apply to unsecured loans, loans below Rs.1,00,000, or the remaining debt below 20% of the original principal. Allows creation of asset reconstruction companies (ARC). Also, allowed banks to sell their non-performing assets to ARC. Banks are allowed to take possession of the collateral property and sell it without court permission.
